#### LIMA WAGE PARITY

As many of you are aware, the pay scale for our Lima District members was 8% below the rest of the G-555 wages. Local 308 merged with Local G-555 in 2012. Local 308's wages at that time were 11% below G-555 wages. The 2015 contract brought the wages to an 8% difference. We are thrilled to announce that the Union has negotiated a new wage increase for our Lima Brothers and Sisters to get them to the G-555 wage rate by July 1, 2017. Lima will receive an additional 5% increase on July 1, 2016 and the remainder of the raise will be given on July 1, 2017.

#### **REMINDER: WELLNESS PROGRAM**

Just a reminder that you and your spouse must have your annual physicals and self-assessments complete and processed by July 31, 2016 in order to avoid the extra \$400 premium next year!

#### **GRIEVANCE ARTICLE 8.2**

The Union was successful in a grievance for the interpetation of Article 8.2 of the Collective Bargaining Ageement. Article 8.2 states, any hours worked over 8, in a 24 hour period, is to be paid at the rate of time and one-half. This applies to being scheduled two shifts in a 24 hour period or being schedued to come in earlier than your normal start time. It does not matter that you are given 8 hours rest. The 8 hour rest rule only applies if you have worked a consecutive 16 hours (Article 8.10).

Please note: this does not apply if you have volunteered to work those hours or it is the start of a new schedule pick.

#### JOINT ACCIDENT REVIEW PROGRAM

The Company and Union entered into a Memorandum of Understanding to address the issue of vehicle safety. Preventable motor vehicle accidents have been on the increase recently. To develop a safe driving culture at Dominion East Ohio, a Joint Accident Review Committee was formed. The Committee will include at least one Union Executive member or designee, a member of the Safety Department and a General Manager and/or Director. The purpose of the Review Committee is to determine the root cause of the accident and adopt ideas to prevent a similar occurrence. Neil Lenhart from the south and Mick Prendergast from the north will represent the Union on the Committee.

#### HRA UPDATE

Our current Collective Bargaining Agreement provides for an individual Health Reimbursement Account (HRA), with a benefit of \$1800 per year for 2016, 2017 and 2018. If you were hired after January 1, 2016 and prior to July 1, 2016 your benefit will be \$900 this year. This money can be used for most out of pocket medical expenses. Please be aware that the date of service cannot be more than one-year-old in order to be eligible for reimbursement.

A new HRA account was also negotiated for those that retiree in 2016, 2017 or 2018. The retiree HRA account will provide \$1500 per year for five years or until you reach age 65. The retiree HRA is a separate account from your active HRA account. Both accounts will be administered by the Utility Workers Union of America, National Health and Welfare Fund, which is TIC International. When you request reimbursement after retirement, you will need to designate which account you want the reimbursement to come from. It is advisable to use up your active HRA account first so it does not go dormant. The advantage after retirement is you can also use either HRA account for your medical premiums.

For employees who retire on or after January 1, 2016 that are age 65 or older or who reach age 65 during their retirement will have access to retire medical plans in the open market through One Exchange, a private health insurance exchange. An annual retiree stipend will be provided into an individual HRA account for eligible retirees. The HRA will be funded annually by Dominion for individuals who enroll in coverage through One Exchange.

#### **JOB SELECTION PROCESS**

The Union has filed 17 grievances so far this year. Eight of those grievances dealt with the job selection process. Last year 32 total grievances were filed. Ten of those grievances dealt with the job selection process. We are obviously having issues with the Company's Targeted Selection Process. In all but two of the cases, we were able to satisfactorily resolve the issues, but not without a struggle. It is apparent the Company needs to re-evaluate their job selection process.

#### **RETIREMENT SESSIONS**

Retirement sessions for those who will be 55 years old by the end of the existing CBA were held June 6-9. Of the over 500 invitees, 223 G-555 members participated in these sessions.

#### **UNION OFFICE UPGRADES**

We have expanded our Union office in Valley View, Ohio from 1600 square feet to 2600 square feet. A five-year lease was signed, with no rent increases, for \$2100 a month. This extra space has given us the opportunity to add a classroom style room to hold Executive Committee meetings.



This space can also be used for educational classes and will be used for our Wage and Grievance meetings during contract negotiations.

#### SAFETY ADVISORY COMMITTEE

The Safety Advisory Committee consists of four members of the Executive Committee. They are Ressie Smith, Rob Newsome, Dominic Rios and recently retired Jim Triska. Jim will be replaced by the newly elected representative from Eastern Shop, Mike Watkins. Jim gave over 40 years of dedicated service to this Union. He was a valuable member of the Committee, a mentor to many, a friend to all and he will be missed. Congratulations to Jim on his retirement; we wish all the best to him.

#### UNITED WAY

Thanks to all for your support of purchasing tickets for the United Way Sports Basket donated by the Union. \$992.00 was raised by the Union and given to United Way. A special thanks to Val McCullars and Wil Soto for visiting the shops and helping with the ticket sales. The winner of the basket was Anthony Desciscio from C&M Northeast shop.

#### **JOB POSTINGS & PROMOTIONS**

Over the past two years we've averaged over 100 union promotions per year! That is a testament to a skilled workforce, as well as a strong Union. Also during that time, we have improved the way job postings are communicated. Not only are they posted at your shop, now every job posting is emailed to all of the Union Reps. In addition, all job postings are now numbered so they can be tracked easier. If you have a question about a particular job posting, contact your Local Union Rep.

#### VACUUM TRUCK DEPARTMENT



The Vacuum Truck Department has been very successful and busy since it was established in the Spring of 2015. The crew on the Vac Truck can repair leaks, replace service lines and cut services without having to get

in the ditch. When working with concrete, a core truck pulls a plug out of the concrete and the repair is made with little or no restoration.

The typical Vac Truck crew consists а three-man of team. The Company recently purchased a fourth and larger vacuum truck at a cost of \$500,000 to over accommodate the work. The extra Union has also



negotiated a new Mechanic classification (Vacuum Truck Mechanic Specialist) with a higher specialist wage rate in order to service the highly specialized trucks.

#### **UPDATED JOB DESCRIPTIONS**

Twenty-year-old job descriptions were revised for three departments. GM&R, Dispatch and Leak Detection job descriptions were updated to reflect current job functions and duties. For those who qualify, the new GM&R job description allows for a shorter time frame to progress through the department. All reference to leak detector equipment operators working as C&M Helpers was eliminated. Along with the Vacuum Truck Mechanic Specialist classification mentioned above, the Union was also successful in resurrecting the Natural Gas Vehicle Specialist A classification as the need arises for those job duties.

### LOCAL G-555 GIVES BACK

In May, members of the Local G-555 Young Workers Committee spent a day at the Akron-Canton Regional Foodbank,

volunteering their time to assist those less fortunate. They packaged 555 lbs. of paper products and boxed up 1635 lbs. of canned goods which equals 1363 meals for the needy in their community. In addition, the Local

Checks were sent to the Greater Cleveland Food Bank, Akron-Canton Regional Foodbank, Second Harvest Food Bank of the Mahoning Valley, The West Ohio Food Bank, and The Southeast Ohio Food Bank. These donations could account for up to 2400 additional meals

for the food insecure members of the communities in which we live and work. While we are excited to help those less fortunate,

we are appalled that in the state of Ohio, so many go hungry. We will continue to do what we can, but until the issues of wealth inequality and lack of living-wage jobs in this area are addressed with real solutions, we are only placing band-aids over severed limbs.
